## **Media reporter declaration**

**§1** I am aware of the risks associated with motor sport events and undertake to comply with the regulations and instructions (written, verbal and visual) issued by the organizers, the race management, the stewards and the police and their representatives without fail and without delay and in particular not to enter restricted zones and safety strips.

**§2** I acknowledge that I am acting at my own risk if I leave the area generally accessible to spectators and the areas expressly designated by the race management, even if my stay there is tolerated by the organizer. Explicitly designated by the race organizers are

- all spectator areas designated as such,
- the entire paddock and service area, including all connecting routes,
- the pit area.

I am aware that it is strictly forbidden to stand in front of the track boundaries (crash barriers, concrete elements, etc.), in restricted zones, on safety strips and at obvious danger points.

**§3** By submitting the media reporter declaration, I hereby declare that I waive all claims of any kind for damages arising in connection with the event against

- the FIA, the CIK, the FIM, the FIM-Europe, the DMSB, the member organizations of the DMSB, their presidents, bodies, managing directors and general secretaries, employees and members,
- the ADAC e.V., the ADAC regional clubs, the ADAC local clubs and the companies affiliated with the ADAC e.V., the DMV e.V., the AvD e.V., their presidents, governing bodies, managing directors, general secretaries, employees and members,
- the promoter/series organizer,
- the promoter, the stewards, the race track owners, the legal entities of the authorities, race services and all other persons connected with the organization of the event,
- the road authorities and
- the vicarious agents and assistants, the legal representatives, the full-time and voluntary employees of all the aforementioned persons and bodies and their members,
- the applicants, drivers, vehicle owners and their assistants.

This does not apply to damages resulting from injury to life, limb or health, which are based on an intentional or negligent breach of duty - including by a legal representative or vicarious agent of the group of persons liable - or other damages which are based on an intentional or grossly negligent breach of duty - including by a legal representative or vicarious agent of the group of persons liable. The waiver of liability applies to claims on any legal grounds, in particular both claims for damages arising from contractual and non-contractual liability and also for claims in tort. Tacit exclusions of liability remain unaffected by the above provision.

**§4** The places expressly allocated by the race organizers for media coverage are noted on the course map. I will view and observe these on the respective event days.

**§5** I am aware that the use of television and video cameras requires the written permission of the owner and administrator of the film and television rights. The DMSB e.V. reserves the right to assert legal claims in the event of infringements. Filming permits must be obtained via the DMSB e.V.

**§6** I am aware that a violation of the above paragraphs will result in the withdrawal of my media accreditation and may have legal consequences.

The exclusion of liability becomes effective upon submission to all parties involved.

**§7** For safety reasons, the use of unmanned aerial vehicles (e.g. drones/microcopters) in the context of motor sport events is generally prohibited. The DMSB reserves the right to impose a fine of €50,000 in the event of an infringement.

The organizer may grant exceptions on his own responsibility, considering the legal requirements and regulations.
